The meeting was called to order at approximately 10:00 a.m.

1. Designation of Chairperson due to Judge Cuervo's absence.

Motion made by Rafael E. Granado, City Clerk, Regular Member to designate Judge Kolokoff as the Chair of the Canvassing Board; seconded by Farosha Andasheva, Qualified Elector, Alternate Member; Vote: 3-0.

2. Approval to commence Vote-by-Mail ballot opening and processing.

The Miami Beach Run-Off Election (Canvassing Board), composed of Jeffrey Michael Kolokoff, County Judge, Substitute Member; Rafael E. Granado, City Clerk, Regular Member; and Farosha Andasheva, Qualified Miami Beach Elector, Substitute Member authorized the Miami-Dade Elections Department to commence the Vote-by-Mail opening and processing.

3. Vote-by-Mail ballot opening and processing.

In the presence of the Canvassing Board, Miami-Dade Elections staff opened the Vote-by-Mail ballots.

Thereafter, the Canvassing Board accompanied the opened Vote-by-Mail ballots to the tabulating room. In the presence of the Canvassing Board, the ballots were processed through electronic

tabulating machines. (See Composite Exhibit "A.") The Canvassing Board was notified by Elections staff that 2 Vote-by-Mail ballots require duplication. The Canvassing Board will review the duplication of these 2 ballots on Tuesday, December 6, 2022, starting at 5:00 p.m.

Canvassing Board Meeting concluded at 1:45 p.m.

Name Badges - Florida Statute 102.141(9) requires that each member, substitute member, and alternate member of the Canvassing Board and all clerical help wear identification badges during any period in which the Canvassing Board is canvassing votes or engaging in other official duties. The identification badges should be worn in a conspicuous and unobstructed area and include the name of the individual and their official position. Jeffrey Michael Kolokoff, County Judge, Substitute Member; Rafael E. Granado, City Clerk, Regular Member; and Farosha Andasheva, Qualified Miami Beach Elector, Substitute Member; and Jean Olin, Esq. wore their identification badge while engaging in their official duties.
