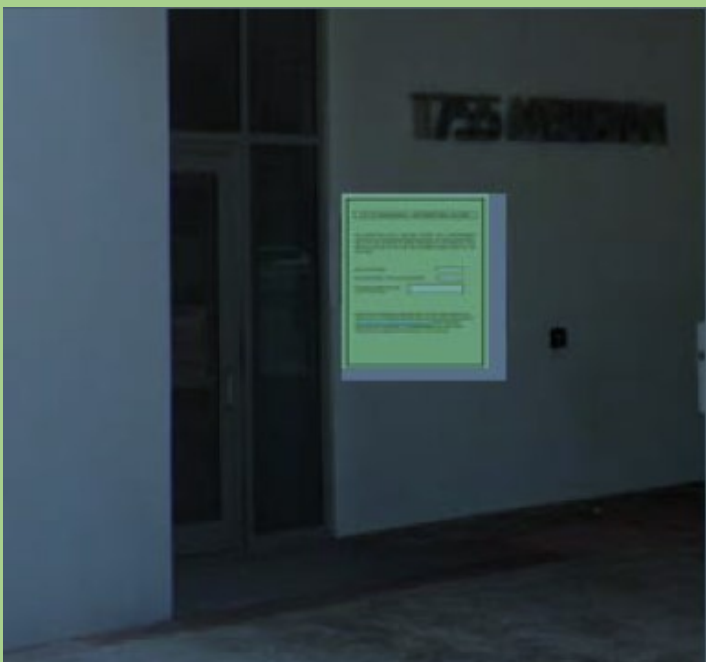


CITY OF MIAMI BEACH INFORMATIONAL POSTING

POSTING INSTRUCTIONS

BUILDING PERMITS AND CORRESPONDING CERTIFICATES OF APPROPRIATENESS ISSUED PURSUANT TO SUBSECTIONS 2.13.7.c.5, THE APPLICANT SHALL MOUNT A LAMINATED POSTING, IN A FORM PRESCRIBED BY THE PLANNING DIRECTOR, AT THE FRONT OF THE PROPERTY, IN A MANNER AND LOCATION CLEARLY VISIBLE FROM THE PUBLIC RIGHT-OF-WAY, INDICATING THAT AN APPLICATION FOR A CERTIFICATE OF APPROPRIATENESS HAS BEEN FILED. THE APPLICANT SHALL PROVIDE EVIDENCE TO THE PLANNING DIRECTOR THAT THE POSTING HAS BEEN INSTALLED ON SITE PRIOR TO THE ISSUANCE OF A BUILDING PERMIT. THE POSTING SHALL BE FOR INFORMATIONAL PURPOSES ONLY AND THE VALIDITY OF ANY BUILDING PERMIT OR CERTIFICATE OF APPROPRIATENESS SHALL NOT BE AFFECTED BY ANY FAILURE TO MOUNT OR CONTINUOUSLY MAINTAIN THE POSTING THROUGHOUT ANY APPLICABLE APPEAL PERIOD ESTABLISHED IN SECTION 2.2.4.8 PROOF OF POSTING MUST BE PROVIDED IN THE FORM OF A PHOTOGRAPH SHOWING 1. THE POSTING IN FRONT OF THE SUBJECT PROPERTY WHERE THE NUMBER CAN BE SEEN (NOT IN FRONT OF THE UNIT OR INTERIOR CORRIDORS), AND 2. A CLOSE-UP OF THE POSTING SHOWING ALL RELEVANT INFORMATION. PHOTOS SHALL BE SCANNED INTO AN ARCHITECTURAL (A-SHEET) FOR PLANNING REVIEW AND APPROVAL AS PART OF THE BUILDING PERMIT APPLICATION. THE POSTING SHALL CONTAIN THE DATE OF POSTING, BUILDING PERMIT NUMBER AND A DESCRIPTION / SCOPE OF WORK. THE POSTING MUST BE PRINTED IN COLOR (GREEN BACKGROUND) ON 11"X17" PAPER WITH BLACK LETTERING AS PROVIDED BELOW. THE NOTICE MUST BE LAMINATED. INFORMATION ON THE POSTING MAY NOT BE MODIFIED IN ANY WAY.
