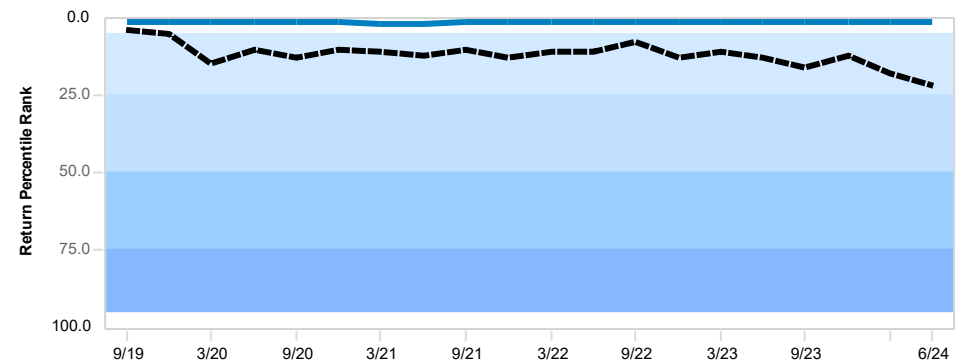


3 Year Rolling Percentile Rank IM Mixed-Asset Target Alloc Moderate (MF)



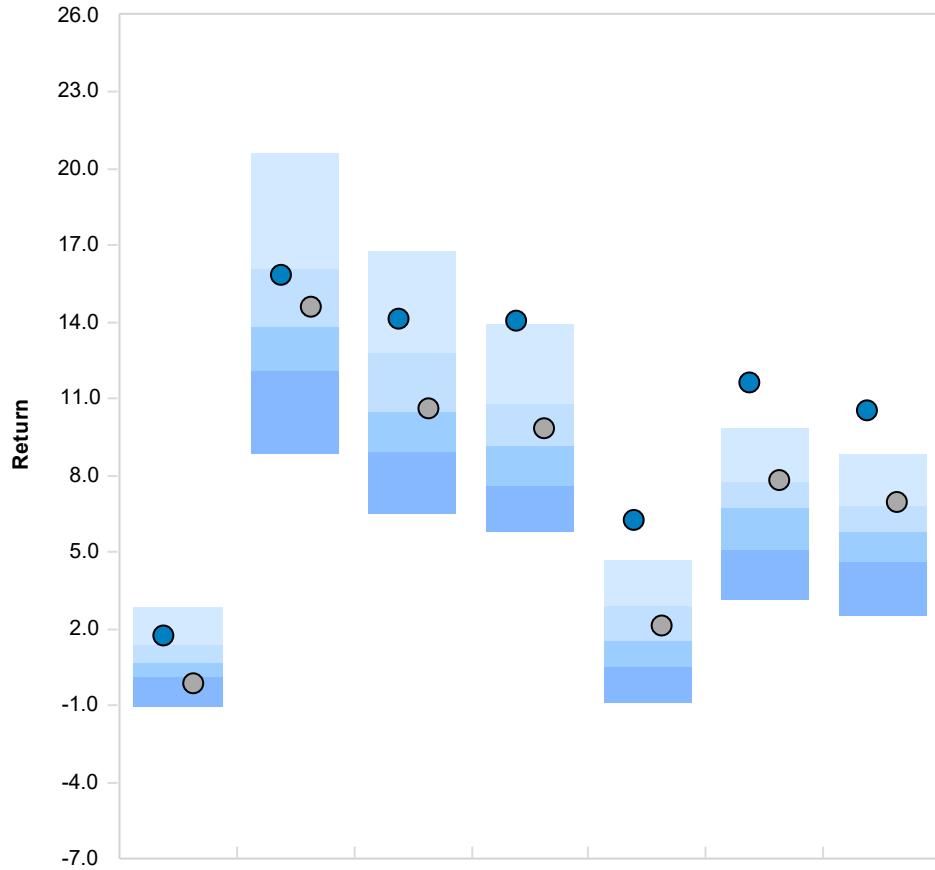

5 Year Rolling Percentile Rank IM Mixed-Asset Target Alloc Moderate (MF)



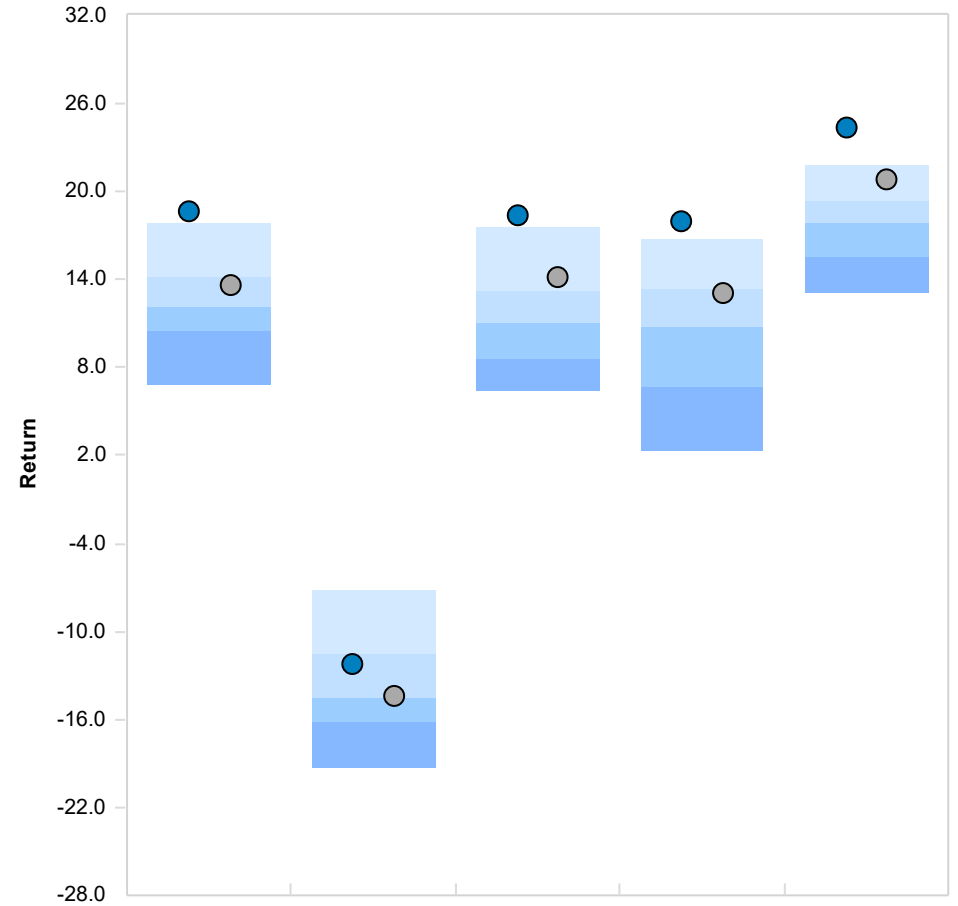
