The City of Miami Beach has approved a Prekindergarten Scholarship Program for the 2025-2026 school year. Descripción General del Programa Prekinder

- Programa patrocinado por la Ciudad proveerá una asignación de hasta \$3,000.00 por año escolar, para cubrir hasta unas 450 horas adicionales de instrucción (hasta 2.5 horas por día por 180 días)
- Se aplicará solamente a instrucción durante el horario escolar regular, no a horas de instrucción después del horario escolar
- Los fondos cubrirán 192 menores residentes de Miami Beach, escogidos por una lotería de solicitantes elegibles

Elegibilidad de Niño para 2025-2026

- Familias que viven en la Ciudad de Miami Beach con un niño(es) que tiene 4 años en o antes del el1 de septiembre, 2025
- Niño nacidos entre el 2 de febrero 2020 y el 1 de septiembre 2021 son elegibles

Comprobante de Residencia en Miami Beach:

- Un/a padre/madre/tutor legal tiene que ser residente de la Ciudad de Miami Beach al entregar la solicitud y durante el año escolar 2025-2026
- Se requiere presentar los documentos de verificación si son elegidos por la lotería:
 - Identificación válida con foto emitida por el estado de la Florida (Licencia de Conducir)

 - Identificación válida con foto emitida por una agencia federal (Pasaporte)
Y TAMBIÉN
 - Una factura mensual con el nombre y dirección del residente, que ha sido enviada por correo regular en los 30 días previos

Comprobante de la edad del Menor

Uno de los siguientes documentos de verificación:

- Certificado de nacimiento
- Certificado de bautismo u otro registro religioso del nacimiento del niño
- una póliza de seguro sobre la vida del niño que haya estado en vigor durante al menos dos años
- un pasaporte o certificado de la llegada del niño a los Estados Unidos
- un registro de vacunación firmado por el médico
- una tarjeta válida de identificación para dependiente militar

Solicitud de Participante: Proceso

- Si su proveedor de PreK preferido no aparece en la lista, comuníquese con ellos para presentar su solicitud
- Fecha límite para entregar la solicitud es el 2 de diciembre 2024
- Solicitantes elegibles (residentes con un menor de la edad requerida) serán añadidos a la lotería del 6 de diciembre 2024
- Después de ser seleccionado y haber verificado los documentos, se requiere que legalicen un acuerdo entre la familia y el Proveedor
- La admisión por parte del proveedor de PreK es un proceso separado a la lotería de PreK de la Ciudad

CMB Payment Rate * PROVIDER will be entitled to receive payment for eligible Program Instructional Hours of service, provided during the regular school hours for PROVIDER's PK Education Program, to be paid at PROVIDER's regular rate or \$6.00 per hour, whichever is less, for up to 2.5 hours per day for 180 days, not to exceed \$3,000 per applicable school year per participant child. Any discounts based on income or other PROVIDER offerings available to the eligible participant will decrease the amount due from the CITY, as applicable. If PROVIDER's tuition rate, as disclosed by the PROVIDER-participant Agreement, exceeds the maximum CMB Program hourly rate of \$6.00 per hour, the participant parent/guardian is responsible for paying any additional sums due and owing PROVIDER.

- an insurance policy on the child's life which has been in force for at least two years;
- a passport or certificate of the child's arrival in the United States;
- an immunization record signed by a public health officer or licensed practicing physician; or
- a valid military dependent identification card or a federal or state government issued identification card.

Note: Children born between 2/2/20 and 9/1/2021 are eligible.

Residency Required Documentation * The City's Chief Learning Officer will process all applications and request the following verification documents from the pool of eligible applicants who could be served under the CMB Program:

- Proof of City of Miami Beach Residency – At least one (1) document from the list of primary source documents and one (1) document from the list of secondary sources of documents, listed below, shall be required:
 - **Primary Sources of Proof of Residency:**
 - Valid Photo ID issued by local state (Driver's license)
 - Valid Photo ID issued by federal agency (Passport)
 - **Secondary Sources of Proof of Residency:** (One (1) of the following monthly bill/statement with the resident's name and address that has been mailed within the last 30 days):
 - Utility bill (FPL, phone, gas, cable)
 - Cell phone bill
 - Bank statement
 - Credit card statement
 - Vehicle insurance bill
 - Mortgage statement
 - Property tax statement (last one received)
 - Voter registration

Note: Internet/Electronic bills are not acceptable proof of domicile.

Notification of Approval * PROVIDER-Participant Agreement. An approved applicant will be required to execute an agreement with an eligible PROVIDER (the "PROVIDER-Participant Agreement"). The PROVIDER-Participant Agreement must describe the authorized use of the CMB Program funds and the tuition rates for PROVIDER's PK Education Program. Upon review and approval of the PROVIDER-Participant Agreement, the City's Chief Learning Officer will provide a confirmatory letter of eligibility for the participant and the selected PROVIDER, which letter shall be counter-signed by the participant parent/guardian and PROVIDER.

Parent Attendance Certification * The participant parent/guardian of each child in the CMB Program shall be required to verify, each month, the participant child's attendance, by executing the prior month's certified child attendance record, prepared by PROVIDER.

Child Participant Dismissal/Voluntary Withdrawal * In the event that a child participant is dismissed or withdraws from the PROVIDER's location ("Unenrolled Participant"), funding for the Unenrolled Participant shall terminate. The Participant parent/guardian shall provide the CITY with notice of an Unenrolled Participant within seven (7) calendar days.

La Lotería: Proceso

- Los fondos para el programa son limitados, no todas las personas en la lista de espera serán contactadas
- El personal contactará a los solicitantes en el orden que sean seleccionados por medio de una lotería computarizada que establecerá el orden numérico en que serán contactados hasta que los fondos se agoten
- Los resultados de la lotería se publicarán en el sitio de web de la Ciudad, incluyendo nombre del padre/madre/ tutor legal, número de confirmación, y número de lotería

Pago al Proveedor

- Se le pagará a los Proveedores a su tasa de pago normal o \$6.66 por hora, o lo que sea menos, hasta 2.5 horas por día por 180 días, a no exceder \$3,000 por cada año escolar correspondiente a cada menor participante.
- Cualquier rebaja basada en nivel de ingreso u otra oferta ofrecida por el Proveedor disminuirá la cantidad debida por la Ciudad.
- Si el costo de la matrícula del Proveedor excede la tasa máxima de \$6.66 por hora aprobada por CMB, el padre/madre/tutor legal se compromete a pagar cualquier cantidad adicional al proveedor.
