In compliance with Florida Statute 316.083(3), for the 2024 Annual Traffic Infraction Detector Report for the period from July 1, 2023 to June 30, 2024, the City of Miami Beach recorded 8,532 notices of violation issued, 26 violations contested, 1 violation upheld, 18 violations dismissed, 2,929 violations issued as uniform traffic citations, 4,597 violations paid, and where collected State funds were distributed in accordance with State Statute 316.0083(4) in the amounts of \$345,100.00 to the General Revenue Fund (\$70.00 per violation), \$49,300.00 to the Health Emergency Medical Services Trust Fund (\$10.00 per violation), and \$14,790.00 to the Brain and Spinal Cord Injury Trust Fund (\$3.00 per violation).
