# Miami Sedano's stores dominate list of who received 7,600 pounds of recalled croquetas

Frozen croquetas recalled because they weren't made in a USDA-inspected facility and had undeclared allergens went mostly to stores in the Miami metropolitan area, especially Sedano's supermarkets.

And the owner of A Tu Gusto explained to the Miami Herald how the USDA establishment number for a Hialeah facility wound up on his brand's croquetas, which are made in unincorporated Lee County's Lehigh Acres area without USDA inspection.

### THE MISTAKES THAT CAUSED THE RECALL

State records say A Tu Gusto has been a registered business in Lehigh Acres since 2018. Owner Jose Tomas Garcia, in an email to the Miami Herald in Spanish, said the croquetas were made at the company's Lehigh Acres facility.

The USDA-Food Safety Inspection Service said the packaging had a USDA mark with "EST. 11154," which is La Autentica in Hialeah.

"Three years ago, we hired a designer to change the model and design of our packaging," Garcia's email said, "and this designer did a search on the internet for other packaging for croquettes and saw

that they all had that seal. It was a mistake to use the seal and, although I am the only one truly responsible, it was due to ignorance."

Garcia said the company is working with the USDA to become an inspected facility.

As for the undeclared allergen, the ingredients list

included the bread crumbs (actually "striped bread") but didn't list the wheat, soy and sesame seeds in the bread crumbs separately as allergens.

El partido también recibió poca ayuda de las campañas de Harris o Biden. En marzo, Biden eligió a tres veteranos operadores demócratas para liderar la campaña en Florida.

Jasmine Burney-Clark,

fundadora y ex directora de Equal Ground Education Fund and Action Fund, fue su directora estatal. El martes, publicó en X sobre las dificultades de la campaña, escribiendo que "no podían permitirse artículos básicos como comida, agua, tarifas del lugar, seguridad o incluso impresión para un solo evento voluntario".

En 2020, la campaña gastó \$50 millones en Florida, en comparación con los \$5 millones este año, dijo.

"La rama de Florida de

esta campaña estuvo plagada de problemas desde el día que comencé", escribió Burney-Clark. "NUNCA estuvimos en juego v todos lo sabía-

En la Legislatura, los demócratas estaban buscando recuperar ocho escaños dar vuelta ocho bancas. Eso habría roto la supermayoría de dos tercios de los republicanos en ambas cámaras, lo que les permite anular las reglas de la Cámara y el Senado y silenciar el debate sin la participación de los demócratas.

En cambio, los demócratas lucharon por conservar lo que tenían. Apenas derrotaron a la representante Carolina Amesty, republicana de Florida Central que fue acusada de falsificación en agosto.

Uno de los pocos puntos positivos para los demócratas fue la reelección de la representante Lindsay Cross, quien enfrentó un serio desafío por parte del comisionado republicano de la ciudad de St. Petersburg, Ed Montanari, en un distrito con una ligera

ventaja demócrata.

Cross dijo que el partido necesita un grupo fuerte de candidatos locales sobre el cual construir, especialmente cuando el partido carece de recursos. No es realista esperar que candidatos que se presentan por primera vez ganen las elecciones estatales, dijo.

"Básicamente, se convierte en un trabajo de tiempo completo durante tres a seis meses como mínimo", dijo. "Creo que se necesita alguien que sepa en qué se está metiendo".

El senador Shevrin Jones, demócrata de Miami Gardens, quien se convirtió en presidente del Partido Demócrata de Miami-Dade este año, dijo que el partido necesita volver a lo básico, construir coaliciones locales y ser más creativo a la hora de llegar a los votantes.

"No podemos ir a ningún otro lado, sino hacia arriba ahora mismo".

Estas armas desestabilizan a las comunidades y agravan los desafíos que enfrentan nuestros vecinos del Caribe, permitiendo que las bandas y las redes criminales transnacionales cometan delitos que socavan la seguridad nacional de Estados Unidos y la estabilidad regional", dijo Meeks. "Debemos invertir en esfuerzos para detener el flujo de armas ilícitas desde nuestras costas al Caribe. Al hacerlo, protegeremos a las comunidades de Estados Unidos, el Caribe y el resto del Hemisferio Occidental".

El informe de la GAO coincide con un estudio del Fondo Monetario Internacional y el Banco Interamericano de Desarrollo publicado esta semana que muestra el alto costo de la delincuencia en América Latina y el Caribe. El estudio concluyó que la delincuencia limita el crecimiento, impulsa la desigualdad y desvía las inversiones privadas y públicas.

El estudio señala que las redes delictivas también se están volviendo más sofisticadas e interconectadas, en todo el hemisferio y en el Caribe específicamente, lo que contribuye a las altas tasas de homicidios.

El estudio de la GAO destaca varias medidas adoptadas por la administración Biden para ayudar a los países del Caribe a combatir el tráfico de armas, pero también destaca las deficiencias de algunas de estas iniciatias. Aunque la ATF ha implementado el uso de eTrace (un sistema de rastreo de armas de fuego basado en Internet) en el Caribe, las barreras lingüísticas y la violencia en Haití han impedido que la policía lo use para rastrear o incluso recuperar armas, según el informe. El entorno de seguridad en Haití también fue citado como razón por la que una Unidad de Investigaciones Penales Transnacionales, establecida por Investigaciones de Seguridad Nacional y anunciada por la vicepresidenta Kamala Harris durante una reunión con líderes caribeños en las Bahamas el año

pasado, no ha despegado. En otras partes del Caribe, los esfuerzos se ven obstaculizados por la corrupción, la falta de coor-

dinación entre los organismos policiales y la falta de un sistema de datos confiable en la mayoría de los países, que todavía utilizan papel para rastrear las armas de fuego.

"Por ejemplo, los funcionarios jamaicanos dijeron que sus registros de armas de fuego están en papel y no están centralizados, lo que los hace menos accesibles y difíciles de analizar. Los sistemas en papel también son vulnerables a la pérdida y destrucción accidental debido a daños por fuego o agua", señala el informe.

Durante el período examinado, Jamaica encabezó la lista de los 25 países y territorios del Caribe con al menos 2,250 armas de fuego recuperadas, según el informe de la GAO. Las entrevistas revelaron que el país no cuenta con el personal ni el equipo necesarios para escanear adecuadamente la gran cantidad de cargamentos que se importan, y se encuentra entre los países en los que las armas de fuego ingresan por puertos no oficiales sin ser inspeccionadas. Las autoridades de Jamaica señalaron que, si bien el país tiene nueve puertos controlados por el gobierno, hay 151 que no están controlados.

"Los funcionarios de la agencia dijeron que los traficantes de armas de fuego ocultan armas de fuego en un envío de exportación legal y falsean el valor del envío, por ejemplo, afirmando que el valor total es inferior a \$2,500 dólares, para evitar tener

que presentar electrónicamente el envío ante el Sistema Automatizado de Exportación (AES) del gobierno y evadir la supervisión del gobierno de Estados Unidos", señala el informe.

Jamaica también se encuentra entre los países del Caribe donde los residentes pueden importar un barril de productos libres de impuestos desde Estados Unidos por año, que se utiliza durante la temporada de fiestas en diciembre. Como resultado, las agencias estadounidenses, de cara a 2023, aumentaron los recursos para controlar la carga que sale de Estados Unidos hacia el Caribe a través de transportistas en el río Miami para combatir el tráfico de armas de fuego del programa de barriles libres de impues-

También se utilizaron perros detectores de armas para ayudar a combatir el tráfico ilícito de armas de fuego y tuvieron éxito en el descubrimiento de armas de fuego. Sin embargo, los funcionarios de la ATF dijeron a los investigadores que no planean seguir brindando esa asistencia debido a los altos costos y a que las condiciones portuarias del país no son lo suficientemente seguras para las operaciones.

Los datos de los 25 países y territorios muestran que las armas de fuego representan la mayoría, o el 88%, de las armas de fuego recuperadas y rastreadas en el Caribe, aunque las armas largas y las

armas automáticas están empezando a convertirse en un problema. De hecho, durante el período de estudio, la cantidad de armas largas presentadas para rastreo en todo el Caribe casi se triplicó hasta alcanzar el 15% de todas las armas examina-

Las autoridades de los Estados Unidos y el Caribe también informan que han observado un aumento en la fabricación privada de

armas de fuego y sus componentes. Las autoridades también dijeron que las impresoras 3D y su capacidad para imprimir piezas de armas de fuego también pueden estar contribuyendo a ese aumento. Una operación de este tipo se descubrió en Trinidad y Tobago. El laboratorio de impresión 3D se había utilizado para producir armas de fuego, dijeron funcionarios de la ATF.

"Las laxas leyes de ar-

mas de nuestro país han creado un círculo vicioso de tráfico de armas de fuego hacia carteles de drogas y organizaciones criminales internacionales, desestabilizando imprudentemente a países de toda la región", dijo Durbin, presidente de la Comisión Judicial del Senado.

"El informe de hoy demuestra la gravedad de este fenómeno, que desencadena violencia, tráfico de drogas y caos", añadió. "Necesitamos frenar el 'río de hierro' del tráfico de armas de fuego y aprobar leves de seguridad de armas que tengan sentido común"

Castro, el congresista de Texas, presentó la Ley ARMAS, que exige el desarrollo de una estrategia interinstitucional integral para interrumpir el tráfico. También es copatrocinador de otro proyecto de ley contra el contrabando de armas, Caribbean Arms Trafficking Causing Harm, CATCH Act, junto con la representante demócrata Sheila Cherfilus-McCormick de Florida. Cherfilus-McCormick, quien también se unió a sus compañeros demócratas en la solicitud del informe de la GAO, dice que su proyecto de ley y los demás esfuerzos "ayudarán a frenar el flujo de armas letales, reducir la violencia y mejorar la seguridad para nuestros vecinos y para nosotros mismos'

# Food facility listeria gets cheese sold by Aldi and other chains recalled in 12 states

Soft cheeses sold under several brands have been recalled from California, Texas, Missouri and nine other states after listeria was found in the manufacturing facility.

Savencia Cheese USA is based in New Holland, Pennsylvania, but said in its FDA-posted recall notice that the problem was in the company's Lena, Illinois, facility.

"Through routine testing, it was identified that processing equipment at the site may have been contaminated with Listeria monocytogenes," the notice said. "While finished product testing has not identified contaminated product, we have

initiated a voluntary recall to retrieve the potentially affected product."

All of the cheeses recalled have a best by date of 12/24/2024.

The cheeses went to stores in California, Texas, Missouri, Illinois, Indiana, Massachusetts, Connecticut, Iowa, New Jersey, Oregon, Colorado and Washington.

Listeria infects about 1,600 people each year in the United States, according to the CDC, killing about 260. The most likely to get the worst of listeria's effects are adults over 65, children under 5 and people with damaged immune systems. Pregnant women can suffer miscarriages and stillbirths. Most people will deal with fever, muscle aches, headaches, flu-like symptoms, possibly confusion and seizures.


