

AFFIDAVIT

As the registered owner or nominated driver of the vehicle, you are deemed responsible for the violation and in compliance with Florida Statute § 316.0083(1) (d)1.a-d, you establish by a sworn affidavit that a statutory exemption applies. Please check the box below that applies to the exemption you are requesting. Mail the complete and notarized affidavit to Dangerous Intersection Safety Program, PO BOX 1730, Denver, CO 80201-1730. Include a copy of the original Notice of Violation and any additional required documentation.

- YIELDING RIGHT-OF-WAY**
My motor vehicle passed through the intersection in order to yield right-of-way to an emergency vehicle or was part of a funeral procession. The affidavit below must be executed in the presence of a notary.

- DIRECTED BY LAW ENFORCEMENT OFFICER**
My motor vehicle passed through the intersection at the direction of a law enforcement officer. The affidavit below must be executed in the presence of a notary.

- VEHICLE OWNER AFFIDAVIT OF NON-RESPONSIBILITY**
My motor vehicle was, at the time of the violation, in care, custody, or control of another person. The affidavit below must be executed in the presence of a notary. Include the name, address, date of birth, and if known, the driver's license number of the person who leased, rented, or otherwise had care, custody, or control of the motor vehicle at the time of the violation. The person you identify will be issued a Nominated Driver Notice of Violation.

- STOLEN VEHICLE**
If the vehicle was stolen at the time of the violation, the affidavit must include the police report indicating that the vehicle was stolen. The affidavit below must be executed in the presence of a notary.

- UNIFORM TRAFFIC CITATION**
A law enforcement officer issued a Uniform Traffic Citation to the driver of the motor vehicle for the same violation at the location of the red light camera. Include the serial number of the Uniform Traffic Citation or for faster processing, you may, but are not required to, include a copy of the Uniform Traffic Citation. The affidavit below must be executed in the presence of a notary.

AFFIDAVIT

You must provide the name, address, date of birth and if known, the driver's license number of the person who was operating the vehicle at the time of the violation in the space provided below before the due date of this Notice of Violation.

The submission of a false affidavit is a MISDEMEANOR of the second degree, punishable as provided in Florida Statute § 775.082 or § 775.083 by a term of imprisonment not to exceed sixty (60) days and/or a fine not to exceed \$500.00.
