- Resident Petition RE: Venetian Causeway Construction (J. Squire)
 - Petition created by residents that has over 100 signatures regarding major construction on Venetian Island. Public Works is leading the project and provides updates on the project. Discussion held.

Crosswalk at W 25 St & Pinetree Drive; Safety Issues w/Crosswalk @ Rakow Center (L. Kolko)

- L. Kolko opened the topic by suggesting there be a crosswalk planned for W 25th St/Pinetree Dr. Transportation to investigate whether that is a plan. Discussion held.
- L. Kolko addressed the committee with community concerns about the crosswalk by the Rakow Center. Transportation noted the suggestions made and will work with the County for improvements. Discussion held.
- o A. Rabin mentioned other areas in the Bayshore neighborhood. Discussion held.

• TDM Program for Large Employers (J. Squire)

J. Squire addressed the committee regarding Transportation Demand Management. Transportation briefed the committee with city voluntary programs such as free Transit Passes for City Employees and also mentioned there are subsidies available for local businesses to take advantage of reduced public transit passes in lieu of municipal parking and Deco Bike membership programs; available on a voluntary basis. The City has partnered with consultants in the past to help with TDM. Discussion held.

Autonomous Electric Passenger Van Service Pilot Program (J. Squire)

J. Squire opened the topic with suggestion the city look into whether
 "Driverless" a pilot program for local public transit is something that would work
 well in the city. Transportation mentioned that a meeting took place a few years
 ago with Beep or Waymo discussing this very topic. A pilot was planned but did
 not pan out due to numerous reasons, including cost. A meeting with Beep will
 be taking place soon. Discussion held.

 - Map of Bicycle Storage locations was provided by Transportation to the Committee. Discussion held.
- Post-Art Basel Update (TRANS)
 - Transportation mentioned the success of the Water Taxi that was available in 2024 in addition to shuttle bus service versus previous years where shuttle service was the only public transit option; Ad campaign directing the public to take advantage of the public transit options rather than drive in; Added Bike Station in Pride Park, which saw a lot of usage; Plans to expand the successful portions of 2024's Art Basel Transportation Plan are being made for 2025. Discussion held.
 - L. Kolko presented community feedback she received regarding the lack of Water Taxi availability, customer experience on shuttle buses, and customer service feedback for Art Basel transit workers.
