- (1) A certificate of insurance for Commercial General Liability in the amount of \$1,000,000 per occurrence named to the City of Miami Beach (Agreement Sec. 12);
- (2) A valid Business Tax Receipt for the current fiscal year (Sec. 14);
- (3) A Fire-Retardant Certificate for umbrellas (if applicable) (Sec. 58);
- (4) A valid grease trap (Fats, Oils and Grease) permit for the period January 1 of the current year — December 31, of the current year (Sec. 14);
- (5) Any documentation of proof of purchase of Concession Facilities that you may (at your discretion) submit for possible reimbursement from the City in the event of a termination of your concession agreement without cause by the City (Sec. 8(B)(i)); and
- (6) A site plan signed and sealed by a Florida licensed engineer or architect (if any change is proposed from your current configuration)(Sec.33).
- (7) Miami Dade County DERM CU stating total number of allowable seating and square footage for your concession. (Sec. 14);
- (8) Copy of Restaurant Menu and information pertaining to any included gratuity (Sec. 78).
